**BYLAW NO. 1518**

A BYLAW TO IMPLEMENT THE MUNICIPAL TICKETING INFORMATION (MTI) SYSTEM

---

WHEREAS Section 264(1)(a) of the Community Charter empowers the City, by bylaw, to designate those bylaws for which Municipal Ticket Information may be used as a means of bylaw enforcement;

AND WHEREAS Section 264(1)(c) of the Community Charter empowers the Council, by bylaw, to authorize the use of any word or expression on a Municipal Ticket Information to designate an offence against a bylaw;

AND WHEREAS Section 265(1) of the Community Charter empowers the Council to, by bylaw, set fine amounts;

AND WHEREAS the Council deems it expedient to authorize the use of Municipal Ticket Information for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences, and to set certain fine amounts;

NOW THEREFORE the Council of the Corporation of the City of Enderby, in open meeting assembled, enacts as follows:

1. The bylaws listed in Column 1 of Schedule A to this bylaw, as amended from time to time, may be enforced by means of a ticket in the form prescribed for the purpose pursuant to Chapter 26, Part 8, Division 3, of the Community Charter.
2. The persons appointed to the job positions or titles listed in Column 2 of Schedule A to this bylaw are designated as Bylaw Enforcement Officers pursuant to Chapter 26, Part 8, Division 3, Section 264.(1)(b) of the Community Charter for the purpose of enforcing the bylaws listed in Column 1 of Schedule A opposite the respective job positions or titles.
3. The words or expressions set forth in Column 1 of Schedules 1 – through 7 to this bylaw pursuant to Chapter 26, Part 8, Division 3, Section 264.(1)(c) of the Community Charter designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.
4. The amounts appearing in Column 3 of Schedules 1 - 7 to this bylaw are the fines set pursuant to Chapter 26, Part 8, Division 1, Section 265.1(a) of the Community Charter for the corresponding offences designated in Column 1.
5. The amounts appearing in Column 3 of Schedules 1 - 7 to this bylaw are the amounts to be paid for the corresponding offences designated in Column 1 if the fine amount is paid within 30 days.
6. This bylaw may be cited as “City of Enderby Municipal Ticketing Information System Bylaw No. 1518, 2013.”
7. “City of Enderby Municipal Ticketing Information System Bylaw Number 1481, 2010” is hereby repealed.
8. This bylaw shall take effect upon the date of its adoption.
